## Notification Nos. 29 to 39-Customs, dated 23rd July, 2024

## **Key Notification for ESDM Sector**

1. Notification No. 34/2024-Customs Date: 23rd July, 2024

**Purpose:** To amend existing customs notifications in the interest of public policy.

#### **Key Amendments:**

- A. Notification No. 25/1999-Customs (28th February 1999):
  - Extension: The deadline for certain provisions is extended from 30th September 2024 to 31st March 2029.
  - List A Updates:
    - **S. No. 18:** Removal **(Deletion)** of "tinned copper interconnect; toughened glass with low iron content and transmittivity of min. 90% and above" after 30th September 2024.
    - New Entries Added:
