85D IT Agreement – Zero Duty on 217 Lines, Protection to Domestic Manufacturing

This agreement was concluded at Singapore in 1996 during the WTO Ministerial. India later joined the ITA is a signatory but asked for more time in the zero duty programme on 217 ITA products which were to be brought to zero by year 2000. It sought, and procured, time to come to zero duty and accordingly brought zero duty by year 2005. India has not signed the ITA-II Agreement signed at the WTO Nairobi Ministerial in 20 December 2015.

The zero duty is bound at WTO and thus cannot be increased under treaty obligation.

The ITA is confined only to the applied duty of customs, that is, the basic duty of customs. The other duties which countervail domestic duty are not part the ITA. Accordingly, the duties of section 3 apply on ITA items. However, please

note that education cess is exempted on ITA goods since the impost will be against the zero duty binding at WTO.

In order to promote manufacture in the country, all inputs going into the manufacture of ITA bound items are also at zero duty.

SAD is exempted on the goods going into manufacture of ITA goods.
