We are pleased to invite entries for the 50<sup>th</sup> Golden Jubilee Edition **ELCINA AWARDS** for **EXCELLENCE** in **ELECTRONICS HARDWARE MANUFACTURING & SERVICES** for **2024-25**. This year marks a momentous milestone and matter of great pride for ELCINA as we complete 50 iconic years of celebrating excellence of our Industry and Entrepreneurs.

The Awards were instituted by ELCINA in 1976 and since last 49 years, the Association has been presenting the same to recognize the achievements of electronics/IT Hardware manufacturing (ESDM) companies in India. The winners of these Awards in previous years can be seen on the ELCINA website (www.elcina.com).

The entries for **ELCINA AWARDS** for **2024-25** are invited from manufacturers of Electronic/IT Hardware Products and Technical Service Providers for outstanding achievements in: -

- 1. Research & Development
- 2. Exports
- 3. Quality
- 4. Excellence in Environment Protection & Sustainable Development
- 5. Business Excellence
- 6. Excellence in Innovation

For the above awards there is a provision for Two award categories, one for Large Industries and the other for Small & Medium Enterprises.

1. Most Promising Start-Ups

For Start-Ups there are two categories viz. R&D and Electronics Manufacturing & Service domains.

## **ELIGIBILITY & GUIDELINES FOR APPLYING**

- A) All Electronics/IT Hardware companies with manufacturing and/or technical design & services base (such as Electronic Design of products, electronic circuits as well as test and certification) in India are eligible to apply for the Awards. Companies engaged in core R&D and / or Technical Support activities are also eligible to apply.
- B) A brief description outlining the qualifying criteria and requirements for each Award is given in the Scheme of Awards which can be downloaded by clicking the respective links.

Kindly note the following:

i) If you are applying for more than one Award, please make separate applications and have them neatly bound with suitable cover, plastic folder, etc.



- ii) Entries for each Award should be submitted in quadruplicate (four copies) separately for scrutiny by Award Committee experts. With a view to reduce use of paper, only one print copy may be submitted along with soft copies on a USB Drive in PDF format.
- iii) The maximum number of pages for each Award entry has been suggested on the last page of the Scheme. Kindly adhere to this requirement to enable quick and proper assessment of the application.
- iv) In respect of Awards for "Quality", "Business Excellence" and "Environment Protection & Sustainable Development", there may be a request for a virtual or personal interaction between the shortlisted companies and in order to obtain first-hand information to decide the winners. In case of personal interaction, the same would be at ELCINA in New Delhi. The Committee may choose to visit the shortlisted Company/s which will be informed and consent taken from the company to be visited. Expenses related to the travel etc. will be borne by the applicant.
- v) A company which received the First Prize last year in any of the Award categories, is not eligible to apply for the same category for this year. They may apply in other categories.

Normally there are two prizes for each category of Awards. A Certificate of Merit may also be considered as a special recognition for deserving entries. However, the number of Awards to be presented is entirely at the discretion of the Award Committee.

<u>IMPORTANT:</u> Applicants may note that no information about Award Committee members will be provided under any circumstances, and the decision of the Award Committee will be final. ELCINA is not liable to entertain any correspondence in this regard.
